Outline of the Benefit

Details of the initiative	A total of 30,000 yen per household will be provided to households that are exempt from the resident tax on a per capita basis for fiscal year 2024. In addition, 20,000 yen per eligible child will be added to the amount for households that share the same livelihood income as the eligible child.	
Eligibility Requirements	Households that meet all of the following requirements are eligible: ① Members of households shall be registered as residents of Setagaya City as of the reference date (December 13, 2024). ② Households shall consist only of those who are exempt from the resident tax on a per capita basis for fiscal year 2024. ③ The household shall not consist solely of the dependents of a person who is subject to the resident tax on a per capita basis. ④ The household shall not include any person who has applied for an exemption from inhabitant tax under a tax treaty. ⑤ The household shall not include any person who has already received a benefit for the same purpose as this benefit from another ward, city, town or village as the head of the household. For the additional child allowance, in addition to the above requirements, households shall meet the following requirements: ① The person who receives the benefit shall share the same livelihood as the child who is eligible for the additional child allowance.	
Children who are eligible for the additional child allowance	Children who meet any of the following conditions: ① Children born on or after April 2, 2006, who are in the same household on the reference date. ② Newborn infants on or after the day following the reference date and before June 30, 2025. ③ A child born on or after April 2, 2006, who lives in a separate household as of the reference date, but shares the same livelihood with the head of the household or a member of the household.






