# 2022 Attitude Survey of Setagaya Residents (Summary)

The Attitude Survey of Setagaya Residents (Summary) is the summary of the 2022 Attitude Survey of Setagaya Residents conducted in May 2022 and has been prepared so that a wider range of city residents may be informed about it.

This year's survey included topics for understanding changes that occur over time such as "Permanent Residence" and "Reception of City Staff," and in addition to these, ones regarding the City's Basic Plan, dementia, and COVID-19.

The results of the survey are used as basic data for carrying out the mission of the city government.

Those who wish further information may view the full 2022 Attitude Survey of Setagaya Residents at the City Civic Information Centers, City Civic Information Corners, city libraries, and on the city website.

Sample Method Two stage stratified random sampling

Methodology Distributed by postal mail and responses collected by postal mail or via the Internet

Survey Period May 19 – June 2, 2022

Effective Responses 1,923

(Breakdown: 1,896 Japanese nationals, 27 foreign nationals)

Effective Responses Rate 48.1%

(Breakdown: 67.6% [1,300] responded by postal mail, 32.4% [623] responded via Internet)





















Regarding experience of Furusato Nozei donations, 28.7% of people said that they had made a one. However, only 1.3% of them had made one to Setagaya City, with the majority having made one to another local government.



#### • Awareness of the reduction in tax revenue from city residents due to Furusato Nozei


Regarding whether they were aware of the reduction in tax revenue from city residents due to Furusato Nozei, 40.5% of people replied "Yes" and 58.2% "No."


#### Awareness of Welfare Hotlines

When respondents were asked if they were aware of the Welfare Hotlines provided by the City for receiving consultation inquiries, 28.0% said that "I have heard of them", 15.3% said that "I have used them", and 9.7% said that "Although I did not know what they were called, I was aware of such efforts"; thus 53.0% of respondents were aware of the Welfare Hotlines, while 46.3% said that "I do not know".




#### Awareness of in-home medical care

Asked how aware they were of in-home medical care, 38.9% of people replied "I have heard of the program (but do not understand the difference between house calls and in-home medical care) but have not used it," 25.4% "I have heard of the program (and understand the difference between house calls and in-home medical care) but have not used it," and 11.3% "I use it for myself, or a person close to me does," giving a total of 75.6% who said they knew about it. 23.9% said they did not know about it.



#### Awareness of ACP (Advance Care Planning)

Asked how aware they were of ACP (Advanced Care Planning), 8.4% of people replied "I know about it to a certain extent" and 2.0% "I know a lot about it," giving a total of 10.4% who said they knew about it. 10.2% replied "I have heard the term 'ACP,' but I do not know what it is about" and 78.9% "I do not know anything about it," giving a total of 89.1% who said they did not know about it.

#### Awareness of the "Setagaya City Hope Ordinance on Coexistence with People with Dementia"

Asked how aware they were of the "Setagaya City Hope Ordinance on Coexistence with People with Dementia," 8.8% of people replied "I have heard of it, but I do not really know what it contains" and 2.2% "I know what it contains," giving a total of 11.0% who said they knew about it. 87.6% replied "I do not know anything about it."




Asked what they want to do to make the city easier to live in if they get dementia, 42.3% of people replied "Write down the things, hopes, etc. that are important to me and tell people around me (family, friends, neighbors, etc.) about them, so that I will still be able to live how I want to even if I get dementia." This was the top answer, and was followed by "Increase the circle of people around me whom I can tell that I have dementia with peace of mind," "Understand and be prepared for dementia by (e.g.) hearing about what living with it is like from people who have it," then the other answers.


When respondents were asked about their awareness of medical facilities and government agencies offering specialized hotline services, 52.0% said "I do not know" and 46.6% said "I know".

When respondents were asked about their awareness of the Act to Eliminate Discrimination against Persons with Disabilities, 71.6% said that "I do not know", 5.4% said that "I am aware of the details", and 21.7% said that "I have heard of it".






When asked about the child-rearing environment in Setagaya City, 5.1% of people replied that "I feel that the town is extremely parenting-friendly," and 42.6% said that "I feel that the town is parenting-friendly," giving a total of 47.7% who said that "I feel that the town is parenting-friendly". 12.9% of people replied that "I don't think that the town is very parenting-friendly," and 1.8% said that "I don't think that the town is parenting-friendly at all," giving a total of 14.7% who said that "I don't think that the town is parenting-friendly".


When asked whether they are participating in local community activities, 12.9% of people replied that "I do participate," and 11.5% said that "I do not participate now, but I would like to in the future," giving a total of 24.4% who said that "I do participate or I would like to in the future". 72.4% of people replied that "I do not participate".


Asked how often they use the accessible community assembly facilities (community halls and residents' meeting rooms), 0.0% of people replied "Every day," 1.6% "Several times a week," 5.7% "Several times a month," 3.0% "Several times within 6 months," and 8.5% "Several times a year," giving a total of 18.8% who said they use them. 80.4% replied "Rarely."



When respondents were asked about their awareness of the community disaster prevention plan, 3.7% said that "I am aware of the details", and 40.6% said that "I have heard of it"; thus 44.3% of respondents overall were aware of the community disaster prevention plan, while 53.8% said that "I do not know".



#### Awareness of the hazard map


Asked how aware they were of the hazard map, 51.9% of people replied that "Yes," they had a copy and 25.2% replied "No, but I have seen it," giving a total of 77.1% who said they knew about it. 10.4% replied "No, and I have never seen it, but I have heard of it" and 10.5% "No, and I have never heard of it," giving a total of 20.9% who said they did not know about it.



#### Thoughts concerning domestic violence


When respondents were asked about their thoughts concerning domestic violence, the highest response was "Violence is the fault of the perpetrator and is not to be tolerated for any reason" (67.9%) followed by "While violence is the fault of the perpetrator, the victim may bear partial responsibility for the cause of the violence as well" (19.7%).












When respondents were asked the effects of the COVID-19 pandemic on your work and lifestyle, 76.7% said that "I have less opportunities to go out with friends and acquaintances for gatherings, trips, etc.", followed by "I have less opportunities to see family members and relatives because I'm unable to return to my hometown", "I feel a lack of physical exercise due to refraining from going out", "I feel stressed due to concerns and anxiety about the infection", "The number of times I go out for everyday shopping (grocery, etc.) has decreased", "My use of cashless payments (making payments ,etc, with credit cards and smartphones) has increased." etc.


